Our Speakers.....

Rebecca McMinn, BSN, RN, MBA is a Registered Nurse, with a Masters in Business Administration. With over 35 years in nursing, the majority of her experience has been in the ICU setting and in hospice. She brings twenty-five years of experience in the hospice field to the Texas based home health and hospice consulting firm, HealthCare ConsultLink. Rebecca served on the Louisiana-Mississippi Hospice Organization's Board, Board Member and Past President of Texas-New Mexico Hospice Organization, and is a member of Texas Association for Home Care & Hospice's Clinical Practice Committee.

Carolyn M. Ingram, BA, MA has served as the Director of New Mexico's Medicaid program since 2003. As Director, Ms. Ingram oversees multiple health insurance programs that provide a full range of physical and behavioral health services to low- and middle-income New Mexicans. Ms. Ingram currently serves as Vice-Chair to the National Association of Medicaid Directors, and holds a position on the New Mexico Medical Insurance Pool Board of Directors.

Cindy Krafft, PT, MS, COS-C has thirteen years of home health experience ranging from front line clinician to Director of Rehabilitation for a six agency system and currently a national consultant. Well received speaker at the state and national level on issues related to the provision of therapy services in home health. She is the current Vice President of the Home Health Section of the American Physical Therapy Association. Cindy presented at VNAA Conference in 2008 as well as state associations conferences for IL, IN, MO, KY, TN, OR, CO and RI. She is published in Home Healthcare Nurse and Success in Home Care. Audio conferences for Decision Health, Fazzi and the American Physical Therapy Association.

Dede Feldman, MA has had a varied career as a journalist, high school and university teacher, and the owner of a small public relations business. As a State Senator from District 13 in Albuquerque's North Valley since 1997, Dede Feldman has already had a big impact on the lives of women, children and people struggling to make ends meet. She is the sponsor of several successful initiatives including the "Graduated Drivers License" system for teens, a mastectomy bill that mandates insurance companies cover a minimum 48 hr. hospital stay, as well as the creation of a Brain Injury Services Fund that provides much needed services to people with head injuries. She currently serves as the Chair of the Senate Public Affairs Committee and the Co-Chair of the Interim Health and Human Services Committee where she is focusing on improving access to quality health care for New Mexicans without insurance and reducing the high cost of prescription drugs. A longtime environmentalist, Feldman has sponsored many bills to preserve the Bosque and conserve water, including the statewide water plan, and a landmark groundwater protection bill passed in 1999. Dede has introduced legislation to reform campaign financing every year she has been in the legislature finally winning approval for public financing of the Public Regulation Commission in 2004, and limitations on campaign contributions in 2009. Dede serves as vice chair of the Interim Legislative Health and Human Services Committee. Sen. Feldman was also appointed by the White House to serve as a member of the State Legislators for Health Reform, made up of state lawmakers across the country with expertise in the area of health care.

Lorena Olmos de Madalena, JD practices in Modrall Sperling's Litigation Dept. Her primary practice interests include Employment Law, Nursing Home Defense and Insurance Coverage. She is a member of the NM State Bar, American Bar Assn. and Hispanic Bar Assn. Some of her honors are Pan American Round Table Award, 2000, Award for Excellence in Int'l and Comparative Law, 2003 and Dean's Award, 2003. She has a BA from Vassar College, A MA from UNM and received her Juris Doctor from UNM School of Law.
